In principle, the teaching delivery methodology is expected to pivot around face-to-face classes. However, according to the decision adopted on July 14 by the Grade Quality Assurance Commission, the course will be taught in person. DYNAMIC ACTIVITIES OF THE TEACHER WITH HIS STUDENTS. CARRYING OUT PRACTICAL ACTIVITIES. The

carrying out practical activities is the essential complement to approach a discipline of extraordinary projection into reality. These activities are necessary for the student to achieve the results of learning no 4 and 5 collected in this guide. The practices will consist mainly of the study of already solved cases in judgments of the Courts in the resolution of assumptions of fact of diverse complexity, comments on texts Legal, chosen sentences or readings and writing of documents for the practice (opinions, reports, memories or other professional documents). Such activities may be carried out individually or in groups.

The works type 6 (only in the part of Civil Law) will consist of the original and founded elaboration of some statutes of

a social economy organization, tutored by the teacher. The dedication of the student will be 5 hours.
